## IV. Items for discussion and action

a. Cost of privacy areas in all bathrooms and locker rooms
Superintendent Coffin noted the cost is being looked into by Mr. Lachance. Mr. Lachance started the process regarding gender identity bathrooms. Privacy in bathrooms and locker rooms to keep all student safe. Mr. Lachance has looked at all the bathrooms and locker rooms in district. Locker room changing will mainly be dealt with in the high school and at Jabish. There are visitor locker rooms at Jabish that could be designated and BHS has 2 visitor locker rooms to look at. The Chestnut Hill swimming pool locker rooms will need to be a discussion with the town. Mr. Lachance is putting together the information regarding costs. Another discussion to have is overnight field trip accommodation, labeling of rooms and access to rooms. At this point the budget impact will be nominal. There would be a private area in every bathroom and locker room.

b. Update on FY18 budget development

Mr. Dunn noted that a template has been created, the level service personnel costs have been updated with an increase of \$495,308. Mr. Dunn noted that 60-70 % of the budget is personnel costs. The next steps are a needs budget and adding the non-payroll items.
